START TIMES AND CALLBACKS: for OPEN and AMATEUR stakes will be posted at the conclusion of each stake on Friday and Saturday evenings. **Judges will impose a system of ROTATION in BOTH the OPEN and AMATEUR stakes, using the 2 ending digits in the TSX as a starting number of the first series as of the close of business on Wednesday, June 19, 2012. Starting number will be posted on York Website yorkretrieverfieldtrialclub.ca and also Canadian Hunting Dog Forum.**

NEW C.K.C. Ruling – Non CKC members who are Canadian, running a wholly-owned dog, cannot win a placement unless they pay a non-member fee to the CKC. Otherwise, Awards and Titles will be cancelled. CKC fee will be paid directly to the CKC, amount unknown.

All entries must be received by the Draw party, Tuesday, June 11, 7:00 PM at the home of Dennis & Cheryl Ritchie. Cheques should be dated no later than June 11, 2012, and made payable to the York Retriever Field Trial Club in Canadian funds. U.S. currency will be accepted at par. LISTING FEE: The listing fee of \$9.50 per dog must be submitted for any dog not having an individual registration number.

Game Birds: Ducks will be used in all stakes

Prizes: Standard CKC Rosettes will be awarded to all dogs who place and to all C.M.'s. Presentations will be made at the completion of each stake.

ALL SCRATCHES MUST BE REPORTED TO THE FIELD TRAIL SECRETARY 24 HOURS BEFORE THE TRIAL. Entry fees will be refunded only for bitches in season or for injured dogs, upon receipt of a veterinarian's certificate. Once the catalogue has been printed, a \$10.00 surcharge will apply.

Notice to Trialer's: Chapter 20, Section 5 of the Field Trial Rules and Regulations states: Any person participating in any capacity at a Field Trial held under these rules shall not be subject to an indignity of any kind. It shall be the duty and obligation of the Club holding the trial to see that this rule is effectively carried out. On report to the trial giving Club of an alleged indignity of any kind the Field Committee of the Club shall forthwith conduct an investigation and shall at once render its decision to the parties concerned. It shall also, within ten days after its trial report to the CKC the nature of the alleged indignity, the names of the parties concerned and its finding. The Board of Directors of the CKC shall have the power to take such actions as it deems fit on receipt of a report indicating that this rule has been violated.
