It is understood that this agreement is binding upon the participants, his or her heirs, executors and assigns.

Please Note: CKC Ruling: Canadian Resident non CKC Members running a wholly owned Dog can not win a placement unless they pay a non member participation fee or a membership fee to the CKC

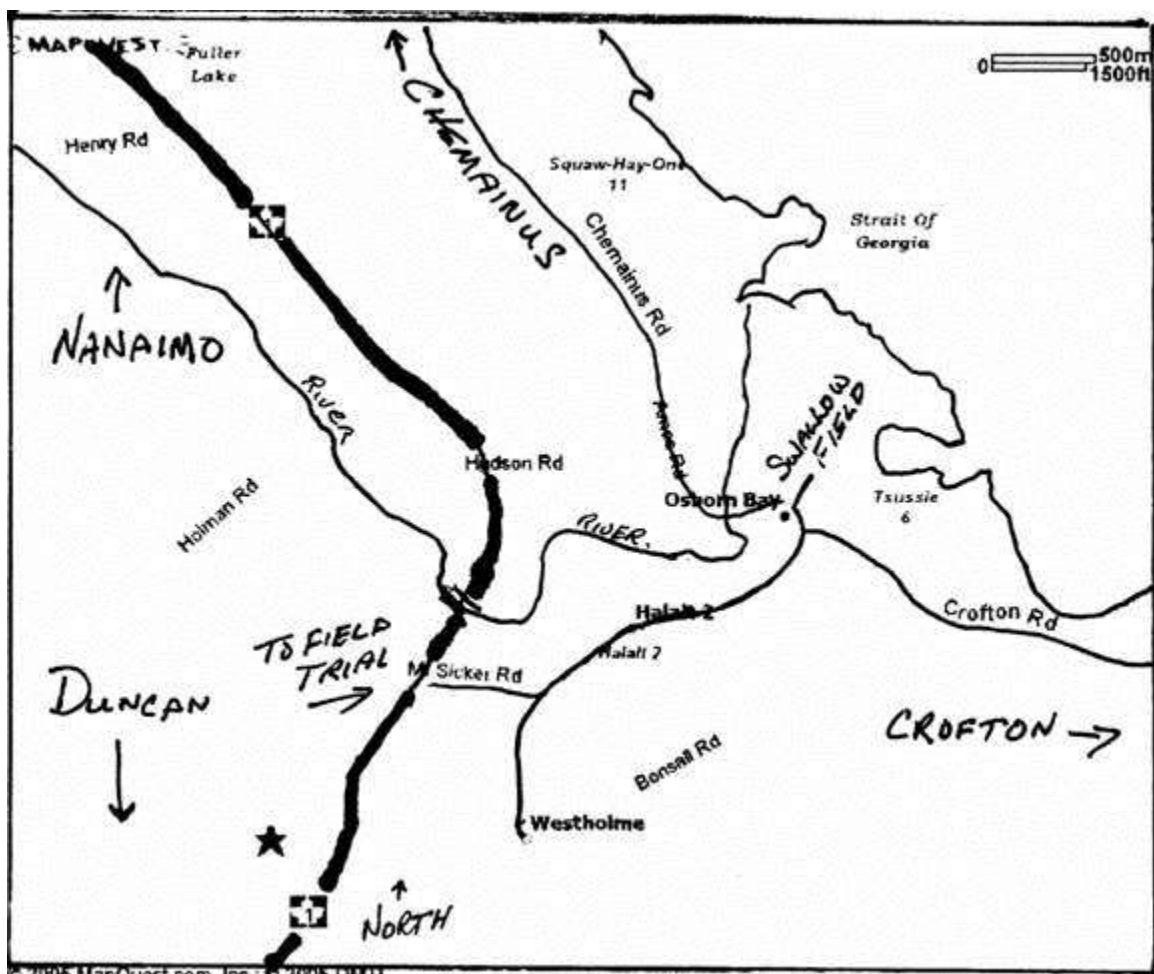
Bitches in season may not compete and must be withdrawn.

REFUNDS: Full refunds will be given for any dog withdrawn because of estrus, injury, illness or death. Other refunds (less a scratch fee of \$10.00 per dog) may be given for good cause at the discretion of the field trial committee. All requests for refunds must be in writing and must be received within 2 days of the last day of the trial and, unless otherwise agreed by the field trial committee, must be accompanied by a Veterinarian's certificate. Males and Females will be run in the order of the draw. Any dog not appearing within 15 minutes of its time to run may be disqualified. **Starting Dog in the Open Stakes to be determined by the TSX closing on Thursday September 26th 2013**

Dead Ducks will be used in all stakes.
Standard CKC Rosettes will be awarded.
