GAME: Dead ducks will be used in all stakes.

NOISE MAKERS: The LOC reserves the right to substitute devices that simulate the sound of a shotgun.

NOTE:

1. The starting dog in the first series of the All-Age Stakes will be determined by using the last two digits at closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index on the **Wednesday** immediately preceding the trial.
2. Rotation: A System of Rotation will be implemented for All-age stakes after the first series (See CKC Rule Book section 6.6.1.c for details).
3. Judges can disqualify any dog which does not appear within 15 minutes of the time designated for its turn to be tried
4. Dogs will run in order unless excused by the marshal for that stake
5. Bitches and dogs will run in the order drawn.
6. Retriever Field Trial Rules & Regulations 6.6.1 (a) allow running out of order, if in the opinion of the Field Trial Committee such will result in a reasonable and desirable saving of time in the conduct of the trial. Committee members while engaged in any administration function are in this classification.

CANADIAN KENNEL CLUB - Non-member participation fee

- a) An annual fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.

The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue."

ENTRY FEES: ALL entries must be accompanied by the appropriate entry fees payable to *THE LABRADOR OWNERS CLUB* and made payable no later than July 10, 2014. **Mailed entries received without funds will not be entered in the draw. Email entries will be accepted on the condition that the entry fee cheque is received by mail prior to the field trial.** US funds will be accepted at par.

In the event a bitch comes into season AFTER the closing date, the entry fee will be refunded upon receipt of a veterinarian's certificate.

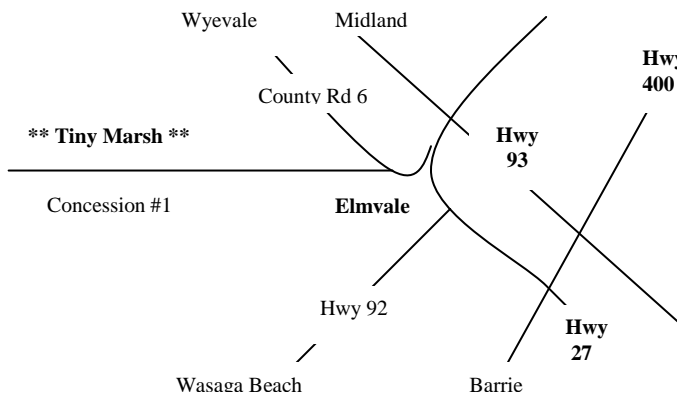
MOTELS
