A listing fee of \$9.41 (including taxes) must accompany each entry for those dogs not registered in Canada, or for those dogs who do not hold an Event Registration Number. CKC registration or ERN must be applied for within 30 days of the trial or all wins and awards will be cancelled. Scratches: Entry fees will be fully refunded for a bitch in season when a vet certificate is provided. All other scratches will be refunded at the Field Trial Committee's discretion, minus an administration fee of \$10. Make all fees payable to the Logan Lake Retriever Club.

Please note: Canadian resident non-CKC members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC.

Dead Ducks will be used at this trial. Males and females will be run in order of the draw. A system of rotation will be used for the start of subsequent series in the All-Age Stakes. Wingers may be used in all stakes. Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial.
