**Entries will be accepted until the draw to be held on May 10, 2014.** Attention U.S. entrants: Personal cheques must be made out for the full amount in Canadian Funds. DO NOT WRITE 'CANADIAN FUNDS' OR 'AT PAR' ON THE CHEQUE, as this is not acceptable at the bank and will be returned. Bank drafts or money orders must be in Canadian Funds.

A listing fee of \$9.96 (including HST) is required for dogs not registered with the CKC. CKC registration or ERN number must be applied for within 30 days of the trial or all wins and awards will be canceled. Application forms are available from the CKC at the above address.

**\*\*New CKC Ruling:** Canadian Resident non CKC Members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC.\*\*

Bitches in season may not compete and must be with drawn. Entry and listing fees paid for any dog withdrawn because of estrus, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the F.T. Secretary before the start of the stake to qualify for a refund. Starting dogs in the Open stake will be determined by the TSX closing on Thursday, May 15th, 2014 and will be based on the running order posted prior to commencement of the trial. A system of rotation will be used for the start of subsequent series.

Ducks will be used at each stake.

**TRIAL HEADQUARTERS AND LOCATION:** The trial headquarters will be along the Shelley Rd, at the old Northwood Scale house. Watch for signs posted. For further directions or information, phone Dan: (250) 962-2246.
