START TIMES AND CALLBACKS: for Open and AMATEUR stakes will be posted at the conclusion of each stake on Friday and Saturday evenings. Judges will impose a system of ROTATION in BOTH the OPEN and AMATEUR stakes, using the 2 ending digits in the TSX as a starting number for the first series as of the closing of business on Wednesday, June 13th.

NEW CKC Ruling – Non CKC members who are Canadians, running a wholly owned dog, cannot win a placement unless they pay a non-member fee to the CKC. Otherwise, Awards and Titles will be cancelled. CKC fee will be paid directly to the CKC.

All entries must be received by the draw party, Wednesday, June 6 at 7:00 PM at the Scott home. Cheques should be dated no later than June 6th, and made payable to **YORK RETRIEVER FIELD TRIAL CLUB** in Canadian funds, US currency will be ACCEPTED AT PAR. LISTING FEE: The listing fee of \$9.61 per dog must be submitted for any dog not having an individual registration number.

Game Birds: Ducks will be used in all stakes

Prizes: Standard CKC Rosettes will be awarded to all dogs that place and to all CM's. Presentations will be made at the completion of each stake.

ALL SCRATCHES MUST BE REPORTED TO THE FIELD TRIAL SECRETARY 24 HOURS BEFORE THE TRIAL. Entry fees will be refunded only for bitches in season or for injured dogs, upon receipt of a veterinarian's certificate. Once the catalogue has been printed, a **\$10.00 surcharge will apply.**

Notice to trialer's: Chapter 20, Section 5 of the Field Trial Rules and Regulations states: Any person participating in any capacity at a Field Trial held under these rules **shall not be subject to an indignity of any kind.** It shall be the duty and obligation of the trial giving Club holding the trial to see that this rule is effectively carried out. On report to the trial giving Club of an alleged indignity of any kind the Field Committee of the Club shall forthwith conduct an investigation and shall at once render its decision to the parties concerned. It shall also, within 10 days after its trial report to the CKC the nature of the alleged indignity, the names of the parties concerned and its findings. The Board of Directors of the CKC shall have the power to take such actions as it deems fit on receipt of a report indicating that this rule has been violated.
