Please note that a gate fee is charged upon entry to Christie Lake Conservation Area.

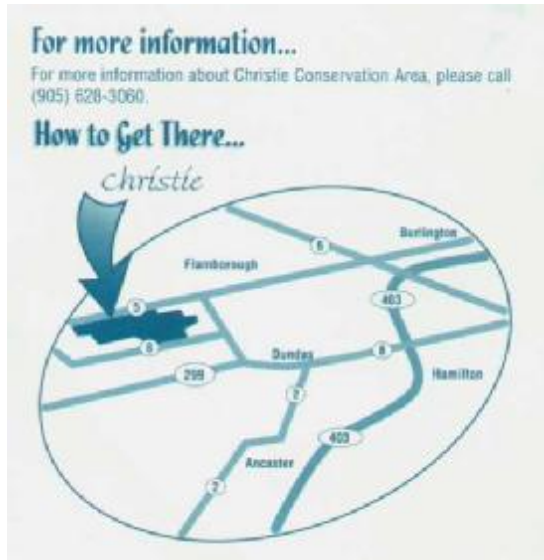

Test Details:

- Standard CKC Rosettes awarded to all qualifying dogs at the completion of each stake.
- Game birds will be used
- Shotguns may not necessarily be used
- All handlers MUST wear dark or camouflage clothing for Master Hunt
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted before the start of the test.
- Separate entry forms MUST be completed for each test
- Handlers may be required to handle a gun during the test. Gun safety is considered part of the test

LISTING FEE: The \$11.30 (HST included) listing fee must be submitted for any dog without an individual CKC registration number or ERN number.

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011)

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

N.S.F. CHEQUES: There will be a \$20.00 charge for N.S.F. cheques.

As these are limited entry tests, payment will be required at the time of entry to secure your spot.
