PLEASE NOTE NEW C.K.C. RULING – NON-CKC MEMBERS WHO ARE CANADIAN, RUNNING A WHOLLY-OWNED DOG, CANNOT WIN A PLACEMENT UNLESS THEY PAY A NON-MEMBERS FEE TO THE C.K.C. OTHERWISE, AWARDS & TITLES WILL BE CANCELLED.

**Running Order:** We will utilize the 2 ending digits in the TSX as of the close of business on Tuesday, September 8, 2020, as a starting number for the first series in the all age stakes. Judges will impose a system of rotation thereafter in the all age stakes. Dogs will run in order of the draw with sexes mixed. Running order will rotate in the Open & Amateur stakes.

By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.

CAUTION: The Labrador Retriever Club of Central Ontario will not be responsible for any loss or damage to any dog or to any equipment whether the result of an accident or otherwise. Furthermore, The Labrador Retriever Club of Central Ontario will assume no liability in the event of an accident or other misfortune to participants, bystanders, club members, workers, or any other individual using any of the properties for any purpose.

Field Trial Officials will be enforcing COVID -19 related guidelines whenever possible, however, The Labrador Retriever Club of Central Ontario will not be held responsible for transmission of the novel coronavirus (SARS-CoV2) and any related illness due to Covid-19.

ATTENTION: Please read and familiarize yourself with the following COVID-19 guidelines. The Labrador Retriever Club of Central Ontario will assume that by submitting your entry that you accept and will abide by all Ontario Provincial recommendations with regards to COVID-19.

- 1. Club officials and participants are required to follow all guidelines that apply.
- 2. Practice social distancing. Avoid congregating in groups as much as possible. Gallery must practice social distancing 6 feet between chairs.
- 3. Avoid shaking hands and hugging.
- 4. Avoid touching dogs or equipment that does not belong to you or is not your responsibility.
- 5. Park with sufficient distance between vehicles.
- 6. Remain near your vehicle until just prior to running and follow the marshals instructions regarding running order and entering holding blinds.
- 7. Any special instructions from the judges will be posted in the holding blind.
- 8. Handlers will be invited to the line in small groups. You might not see the test dog run but will have the opportunity to see other dogs run from the holding blinds.
- 9. Gloves must be worn by handlers
- 10. Birds will be placed into a bucket or onto bird rack by the handler and dealt with by the marshal once the dog and handler leave the line. Follow the instructions from the marshal.
- 11. Hand sanitizer will be available.
- 12. All handlers should bring their own radio as the marshal will use it to communicate when it is your turn to enter a holding blind and any other instructions. Tune your radio to channel 5 for marshal instructions.
